**PURPOSE:**

The purpose of the 4-H Canada category of Honourary Member is to recognize individuals who have made outstanding contributions to the 4-H program in Canada. 4-H Canada invites its members to submit nominations for this category.

**ELIGIBILITY OF INDIVIDUALS FOR NOMINATIONS:**

The nominee must have:

- Involvement in 4-H at one or more levels of 4-H work in Canada for a minimum of 10 years in total.
- May have been involved in any capacity of 4-H whether volunteer, professional or another capacity.
- Individuals must have demonstrated significant initiative; leadership and a positive impact on 4-H.

**ELIGIBILITY OF NOMINATORS:**

- Nominators must be affiliated with 4-H Canada through membership.
- Nominations for Honourary Member candidates may be submitted by groups or individuals.

**THE INDUCTIONS AND RESPONSIBILITIES OF THE 4-H CANADA:**

- The induction will take place at the 4-H Leadership Awards January 31, 2019.
- 4-H Canada will cover costs incurred for travel (air or ground), and accommodations for the inductee to attend the 4-H Leadership Awards in accordance with Travel Policies.
- Inductee will receive one additional complementary guest ticket to attend the 4-H Leadership Awards.

Provide the information carefully and thoughtfully, as this is the only information the Board Development Committee will use to make the selection. Please include TWO letters of reference that confirm information, dates and support the nomination.
